* **AFTER AUGUST 1, 2019** the \$400 Enrollment Fee and \$600 toward Tuition (per student) must be paid with the online Enrollment.

PAYMENT OF TUITION AND FEES

- Tuition and Fees are collected in advance of services rendered and **are non-refundable**. A payment agreement through FACTS Tuition Management must be set up and the annual FACTS fee paid as part of the enrollment process.

DISCOUNTS

- TSCA does not offer automatic church-related or multiple-student discounts. However, families may apply for financial assistance.

FINANCIAL ASSISTANCE

- TSCA actively pursues grants and scholarship funding to help meet the need of families that find the cost of tuition more than they can handle within their budget. To be considered for financial aid, an online application to FACTS Grant & Aid Assessment must be submitted by **April 1**. New families must submit upon enrollment. FACTS charges an application fee and awards are only granted after the application has been verified. Awards are allocated annually on the basis of family need and acceptable student academic performance and conduct must be maintained to avoid loss of financial aid. In addition, the student may be required to write letters of appreciation to donors and the parent may be expected to volunteer service hours.

REFERRAL CREDIT

- \$1,000 Tuition Credit:** Offered to current families enrolled at TSCA since September 1, 2018 when they refer a NEW family to TSCA. To qualify, the new family must enroll by September 1, 2019, name the referring family at the time of enrollment, and remain in good standing financially, academically, and in conduct throughout the year. The referring family will be given options for receiving the credit after the end of the second six weeks of school providing both families have met all of these requirements.

EARLY WITHDRAWAL

- When a student withdraws from Tyler Street Christian Academy prior to the end of the school year, tuition is due through the end of the month in which the student withdraws. In addition, there is a **penalty amount equal to one-tenth of full tuition**.

E-BOOKS

- Students in grades 5 - 12 use e-books on a school-provided laptop on which all required software has been installed. The only hard back textbooks that might be required would be ones needed for Dual Credit and College Board AP courses.

BEFORE AND AFTER SCHOOL CARE

- Before and After School Care is available from 7:00 AM to 6:00 PM on school days for students enrolled at TSCA. After school care closes at **3:00 PM on the last day before Christmas and Summer Breaks**.
- Students who will regularly use daycare should be enrolled in the program; those who need it only occasionally may remain on "drop-in" status. However, **payment is due on the day of the drop-in**.
- It is mandatory that all students on the TSCA campus be under the supervision of an adult. Therefore, students who are on campus unsupervised will be required to go to daycare and are subject to the appropriate fee as follows:
 - K5 - 5th grade students who arrive on campus before 8:00 AM
 - 6th - 12th grade students who arrive on campus before 7:45 AM
 - K5 - 5th grade students who remain on campus after 3:45 PM (12:15 PM on early dismissal days)
 - 6th - 12th grade students who remain on campus after 4:00 PM (12:15 PM on early dismissal days)

BOTH Before AND After School Care	\$1,300/year
Late Pick-Up Fee	\$2.00 per minute

DROP-IN: Due on the day of the drop-in, or automatically added to the next scheduled FACTS payment

Before School Care	\$6.00 per day
After School Care	\$12.00 per day
Early Dismissal Days	\$18.00 per day
Late Pick-Up Fee	\$2.00 per minute
